Descripción

Objetivo:

La jornada tiene como objetivo prestar apoyo en la definición de los términos de referencia (TdR) que describen de manera detallada el enfoque y metodología que deben seguir las evaluaciones que se planteen de las Estrategias de Especialización Inteligente (S3).

Así mismo, se tratarán aspectos de importancia en el proceso de evaluación, tales como: la mejora de la calidad de las evaluaciones, la elección de enfoques y metodologías apropiadas o la formulación de preguntas de evaluación.

<p>Elliot Stern</p>	<p>University of Lancaster</p>	<p>Elliot Stern was a founding Academician (now Fellow) of the UK Academy of Social Sciences and helped establish both the European and UK Evaluation Societies. He has been a practitioner working with professionals and policy makers for many years and worked with Ministries and public Agencies to design and implement evaluation systems. In recent years he has become interested in ‘frontier’ methodologies in evaluation that can improve confidence in the ability of evaluation to identify ‘causal’ relationships and explain as well as describe.</p> <p>Working on energy policies for the UK government; on international development for OECD and the World Bank; and on territorial and Structural Fund policies for the EU has provided an ideal laboratory to see how far rigorous evaluation methods can be accommodated in complex policy settings.</p> <p>At this moment, the problems he is interested in continue to be on the boundary of policy, practice and research. These problems include: how to better integrate evaluation into policy learning; strengthening evaluation quality and credibility; and adapting evaluation to complex and crisis prone policy environments.</p>
<p>Thomas Delahais</p>	<p>Quadrant Conseil</p>	<p>Thomas Delahais manages and works on evaluation projects and strategic consultancy assignments for international and European institutions, as well as for French local and national authorities. He also trains civil servants in evaluation and provides long-term support to organisations in setting up their evaluation systems.</p> <p>Thomas is a specialist in impact evaluation, particularly theory-based impact evaluation approaches such as contribution analysis. He is interested in using such approaches in complex settings with high levels of uncertainty, such as social and environmental transition initiatives.</p> <p>Thomas joined the Cohesion Policy Evaluation Helpdesk in 2021 and is a member of the core team in charge of the ex-post evaluation of the ERDF 2014-2020. He previously worked for 10 years as Director of Innovation at Euréval, a pioneering French evaluation consultancy.</p>

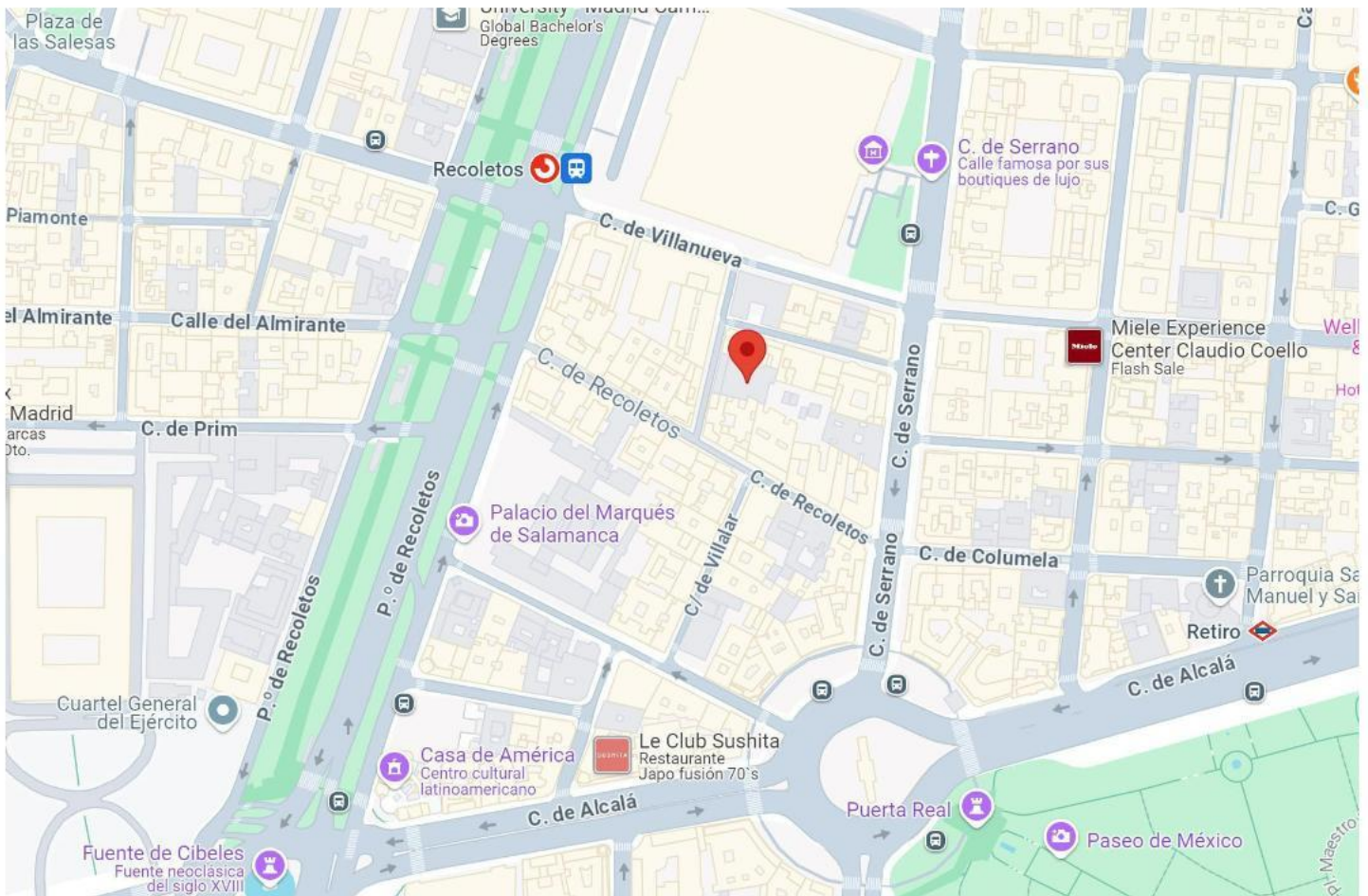
